ALL that piece, parcel or lot of land, situate, lying and being in the City and County of Greenville, State of South Carolina, on the southwestern side of Carolina Avenue and being known and designated as Lot No. 4, Block I, Section 5, East Highland Estates as shown on plat thereof recorded in the RMC Office for Greenville County in Plat Book K at Pages 79 and 80, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southwestern side of Carolina Avenue at the joint front corner of Lots Nos. 4 and 5 and running thence along the joint line of said Lots, S. 58-59 W. 170 feet to an iron pin; thence N. 31-01 W. 50 feet to an iron pin; thence along the joint line of Lots Nos. 3 and 4, N. 45-49 E. 174.7 feet to an iron pin; thence along the southwestern side of Carolina Avenue, S. 31-01 E. 90 feet to the point of beginning.
