MORTGAGE OF REAL ESTATE

To All Whom These Presents May Concern:

Thomas E. Allen and Kay L. Allen

(hereinafter referred to as Mortgagor) (SEND(S) GREETINGS:

WHEREAS, the Mortgagor is well and truly indebted unto FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, SOUTH CAROLINA (hereinafter referred to as Mortgagee) in the full and just sum of

conditions), said note to be repaid with interest as the rate or rates therein specified in installments of

Nine and 39/100-----₍₅ 309.39)) Dollars each on the first day of each month hereafter, in advance, until the principal sum with interest has been paid in full, such payments to be applied first to the payment of interest computed monthly on unpaid principal balances, and then to the payment of principal with the last payment, if not sooner paid, to be due and payable 30 years after date, and

WHEREAS, said note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty days, or if there shall be any failure to comply with and abide by any By-Laws or the Charter of the Mortgagee, or any stipulations set out in this mortgage, the whole amount due thereunder shall at the option of the holder thereof. become immediately due and payable, and said holder shall have the right to institute any proceedings upon said note and any collaterals given to secure same, for the purpose of collecting said principal due, and interest, with costs and expenses for proceedings; and

WHEREAS, the Mortgagor may hereafter become indebted to the Mortgagee for such further sums as may be advanced to the Mortzagor's account for the payment of taxes, insurance premiums, repairs, or for any other purpose;

NOW, KNOW ALL MEN. That the Mortgazor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgazor to the Mortgazor's account, and also in consideration of the sum of Three Dollars (53,00) to the Mortgazor in hand well and truly poid by the Mortgazor at and before the sending of these presents, the receipt whereof is hereby acknowledged, has granted, burgained, will, and released, and by these presents does grant, bargain, sell and release unto the Mortgazor at the following date of the sending of these presents. Mortgagee, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, at the northeastern corner of the intersection of Brentwood Way and Sandhurst Drive and being known and designated as Lot No. 98 on a plat of BRENTWOOD SUBDIVISION, Section No. III, recorded in the RMC Office for Greenville County in Plat Book 5-D at Page 42, and having, according to said plat, the following metes and bounds, to-wit:

Beginning at an iron pin on the northeastern side of Sandhurst Drive, joint front corner of Lots 98 and 99 and running thence N.70-57 E. 149.96 feet to an iron pin; thence S.19-55 E. 140 feet to an iron pin on the northern side of Brentwood Way; thence with said Street, S.70-57 W. 125 feet to an iron pin at the northeastern dorner of the intersection of Brentwood Way and Sandhurst Drive; thence with the curve of said intersection, the chord being N.64-29 W. 35.62 feet to an iron pin on the northeastern side of Sandhurst Drive; thence with said Drive, N.19-55 W. 115 feet to the point of beginning.
