MORTGAGE OF REAL ESTATE

To All Whom These Presents May Concern:

JESSE DONALD ARROWOOD

(hereinafter referred to as Mortgagor) (SEND(S) GREETINGS:

WHEREAS, the Mortgagor is well and truly indebted unto FIRST FFDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, SOUTH CAROLINA chereinafter referred to as Mortgagee in the full and just sum of

EIGHTEEN THOUSAND FIVE HUNDRED AND NO/100----- (\$18,500.00)

Dollars as evidenced by Mortgagor's promissory note of even date herewith which note. does not provide a provision for escalation of interest rate (paragraphs 9 and 10 of this mortgage provides for an escalation of interest rate under certain

conditions), said note to be repaid with interest as the rate or rates therein specified in installments of ONE HUNDRED

WHEBEAS said note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty days, or if there shall be any finding to comply with and abide by any By-Laws or the Charter of the Mortgagee, or any stipulations set out in this mortgage, the whole amount due thereunder shall at the option of the holder thereof, become immediately due and pay dile, and said helder shall have the right to institute any proceedings upon said note and any collaterals given to secure same, for the purpose of collecting said principal due, and interest, with costs and expenses for proceedings; and

All that certain piece, parcel or lot of land with all improvements thereon or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southeastern side of RISON ROAD being shown as LOT 21 on a plat of the PROPERTY OF JAMES ARROWOOD, prepared by Webb Surveying and Mapping Company, recorded in Plat Book RRR at page 45 in the RMC Office for Greenville County and having according to said plat the following metes and bounds, to-wit:
