C., which is recorded in the RMC office for Greenville County in Mortgage Book 1419, page 868, title to which property is now being transferred to the undersigned OBLIGOR(S), who has the description of the Mortgage loan and to pay the balance due thereon; and assumption of the mortgage loan, provided the interest rate on the balance due is increased from 111118 (17/2) % to a present rate of Nine (9%) 7, and can be escalated as hereinafter stated. NCW, THEREFORE, this agreement made and entered into this 11th day of February, 1978, by and between the ASSOCIATION, as mortgagee, and Bobby R. Sentell, Jr. and Vicki V. Sentell WITNESSETH: In consideration of the premises and the further sum of \$1.00 paid by the ASSOCIATION to the OBLIGOR, receipt of which is hereby acknowledged, the undersigned parties agree as follows:

(1) That the loan balance at the time of this assumption is \$31,300.00; that the ASSOCIATION is presently increas-of \$ 251.86 each with payments to be applied first to interest and then to remaining principal balance due from month to month with the first monthly payment being due March 1 _, ₁₉78_ (2) Should any installment payment become due for a period in excess of (15) fifteen days, the ASSOCIATION may collect a "LATE CHARGE" not to exceed an amount equal to five per centum (5%) of any such past due installment payment. (3) That all terms and conditions as set out in the note and mortgage shall continue in full force, except as modified expressly by this Agreement. (4) That this Agreement shall bind jointly and severally the successors and assigns of the ASSOCIATION and OBLIGOR, his heirs, successors and assigns.
