All that certain piece, parcel or lot of land with all improvements thereon or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot No. 41 as shown on plat of Fresh Meadow Farms, recorded in plat book S page 61 of the RMC Office for Greenville County, S. C., and having according to said plat the following metes and bounds, to-wit:

Beginning at an iron pin on the northeast side of Pine Ridge Drive, the joint front corner of Lots Nos. 40 & 41; thence with the curve of Pine Ridge Drive S. 55-38 E. 50 feet to an iron pin; thence continuing with the curve of said street N. 79-38 E. 42.7 feet to an iron pin; thence continuing with the curve of said street N. 70-05 E. 117 feet to an iron pin corner of Lot No. 14; thence with the line of lots 14 and 13, N. 44-30 W. 163.4 feet to an iron pin corner of lot No. 40; thence with the line of said lot S. 45-30 W. 179.6 feet to the beginning corner.
