Norma K. Grizzard (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Twenty-four Thousand and 00/100 (\$24,000.00)----- DOLLARS

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Fairview Township, in the Town of Fountain Inn, being known and designated as Lots 1 and 2 on a plat made by W. N. Willis, Engineer, entitled "Survey for Donald L. Rhinehart and Bonnie C. Pace," recorded in the RMC Office for Greenville County, South Carolina, in Plat Book 5N at Page 47, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern side of Georgia Street Extension, at the northeast corner of the property herein being conveyed and runs thence S. 10-01 W. 266.5 feet to an iron pin; thence S. 80-26 W. 184.0 feet to an iron pin on the eastern side of a 50 foot street; thence along said street, N. 7-12 W. 221.3 feet to an iron pin on the south side of Georgia Street Extension; thence along Georgia Street Extension, N. 74-47 E. 110.0 feet to an iron pin; thence continuing along said street, N. 73-34 E. 156.7 feet to the beginning corner, and being the same property conveyed to Bennett C.
