WHEREAS, the Mortgagor is justly indebted unto the Mortgagee in the sum of TWELVE THOUSAND ONE HUNDRED


FIFTY-SEVEN AND 50/100Dollars (\$12,157.50), (the "Mortgage Debt"), for which amount the
