All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, at the southeastern corner of the intersection of Sheffield Drive and Third Day Street and being known and designated as Lot No. 43 as shown on a plat of CANTERBURY Subdivision, Section I, prepared by Heaner Engineering Co., Inc., dated March 22, 1972, and recorded in the RMC Office for Greenville County in Plat Book 4-N at Page 69, and having, according to said plat, the following metes and bounds, to-wit:
