21st THIS MORTGAGE made this among John R. Gress & Gloria Gress _ (hereinafter referred to as Mortgagor) and FIRST UNION MORTGAGE CORPORATION, a North Carolina Corporation (hereinafter referred to as Mortgagee):

AND WHEREAS, to induce the making of said loan, Mortgagor has agreed to secure said debt and interest thereon (together with any future advances) and to secure the performance of the undertakings prescribed in the Note and this Mortgage by the conveyance of the premises hereinafter described:

NOW, THEREFORE, in consideration of the aforesaid loan and the sum of Three Dollars (\$3.00) cash in hand paid to Mortgagor, the receipt of which is hereby acknowledged, Mortgagor hereby grants, sells, conveys, assigns and releases to Mortgagee, its successors and assigns, the following described premises located in Greenville . County, South Carolina:

ALL that lot of land situate on the eastern side of Barrett Drive in the County of Greenville, STate of South Carolina, being shown as Lot 89 on a plat of Burdett Estates, dated February 1971, prepared by Dalton and Neves Company, recorded in Plat Book 4-X at Page 60, in the RMC Office for Greenville County, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern side of Barrett Drive at the joint front corner of Lot 88 and Lot 89 and running thence with Lot 88, S. 68-42 E. 151.1 feet to an iron pin at the joint rear corner of Lot 88 and Lot 89; thence with Lot 86 and Lot 92, S. 14-16 W. 105 feet to an iron pin at the joint rear corner of Lot 89 and Lot 90; thence with Lot 90, N. 75-44 W. 150 feet to an iron pin on the eastern side of Barrett Drive; thence with said Drive, N. 14-16 E. 123.5 feet to the point of beginning.

THIS being the same property conveyed to the mortgagors herein by deed of Trammell Bros. Builders & Developers, a General Partnership, dated July 18, 1975, and recorded in the RMC Office for Greenville County, South Carolina on July 25, 1975 in Deed Book 1021 at Page 834.

THIS mortgage is second and junior in lien to that mortgage given to North Carolina National Bank (now NCNB Mortgage Corporation) in the original amount of \$26,000.00, which mortgage was recorded in the RMC Office for Greenville County, South Carolina on July 25, 1975 in Mortgage Book 1344 at Page 697.

Together with all and singular the rights, members, hereditaments and appurtenances to said premises belonging or in anywise incident or appertaining. Including but not limited to all buildings, improvements, fixtures, or appurtenances now or hereafter erected thereon, including all apparatus, equipment, fixtures, or articles, whether in single units or centrally controlled, used to supply heat, gas, air conditioning, water, light, power, refrigeration, ventilation or other services, and also together with any screens, window shades, storm doors and windows, screen doors, awnings, stoves and water heaters (all of which are declared to be a part of said real estate whether physically attached thereto or not).

TO HAVE AND TOHOLD the same with all privileges and appurtenances thereunto belonging to Mortgagee, its successors and assigns, forever, for the purposes hereinafter set out and Mortgagor covenants with Mortgagee, its successors and assigns, that Mortgagor is seized of, and has the right to convey, the premises in fee simple; that the premises are free and clear of all encumbrances except for a prior Mortgage, if any; and that Mortgagor will warrant and defend title to the premises against the lawful claims of all persons whomsoever.

MORTGAGOR COVENANTS with Mortgagee, its heirs, successors and assigns as follows:

- NOTE PAYMENTS. Mortgagor shall make timely payments of principal and interest on the above mentioned Note in the amounts, in the manner and at the place set forth therein. This Mortgage secures payment of said Note according to its terms, which are incorporated herein by reference.
- TAXES. Mortgagor shall pay all taxes, charges and assessments which may become a lien upon the premises hereby conveyed before any penalty or interest accrues thereon and shall promptly deliver to Mortgagee (at its request) official receipts evidencing payment thereof. In the event of the passage after the date of this Mortgage of any law imposing a federal, state or local tax upon Mortgage or debts secured thereby, the whole principal sum (together with interest) secured by this Mortgage shall, at the option of Mortgagee, its successors and assigns, without notice become immediately due and payable.
