"ALL that certain piece, parcel or lot of land, with all improvements thereon, or bereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the Woodside Mill Village in the Town of Simpsonville, and being more particularly described as follows: Lot 46 as shown on a plat entitled "A Subdivision of Woodside Mills, Simpsonville, S. C." made by Piedmont Engineering Service, Greenville, South Carolina, February, 1953, and recorded in the Office of the RMC for Greenville County, South Carolina, in Plat Book GG at page 5. According to said plat, the within described lot is also known as No. 31, "A" Street and fronts thereon 84 feet.

Being the same property conveyed to the mortgagors herein by deed of Mortgagee of even date, to be recorded.
