(hereinaster referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Forth Thousand Three Hundred Seventy-five and no/100----- DOLLARS

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the town of Simpsonville, on the northern side of Brentwood Way, being known and designated as Lot No. 70 on a plat of Brentwood, Section 2, made by Pidemont Engineers and Architects, dated May 19, 1972, recorded in the R.M.C. Office for Greenville County, South Carolina in Plat Book 4-R, Page 5 and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northern side of Brentwood at the pint front corner of lots nos. 70 and 71 and running thence with the common line of said lots N. 19-03 W. 150.0 feet to an iron pin in the line of property now or formerly belonging to Jeff R. The above described property is the same property conveyed to W. H. Knight and Fran Lee Jordan by deed of John W. Ball and Eiko N. Ball of even date to be recorded herewith.

In addition to and together with the monthly payments of principal and insterest under the terms of the Note secured hereby, the mortgagors promise to pay to the mortgagee a monthly premium necessary to carry private mortgage guaranty insurance until the principal balance reaches 80% of the original sales price or appraisal, whichever is less. The estimated monthly premium for the first nine years will be .02% of the original amount of the loan. The estimated monthly premium for each year thereafter will be .01% of the original principal balance of this ban.
