NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Greenville, and being known and designated as Lot No. 274 as shown on a plat entitled "SECOND REVISION OF TRAXLER PARK", recorded in the RMC Office for Greenville County in Plat Book "G", at page 116, and having according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northern side of Rock Creek Drive at the joint front corner of Lots Nos. 275 and 274, and running thence with the line of Lot No. 275 N. 25-23 W. 264 feet to an iron pin at the joint rear corner of Lots Nos. 274, 275, 256 and 257; thence with the line of Lot No. 257 N. 71-12 E. 70.5 feet to an iron pinat the joint rear corner of Lots Nos. 273, 274, 257 and 258; thence with the line of Lot No. 273 S. 25-23 E. 253.6 feet to an iron pin on the northern side of Rock Creek Drive; thence with the northern side of Rock Creek Drive N. 67-40 E. 70 feet to the point of beginning.
