WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as the northern one-half of Lot No. 13 on Plat of East Overbrook, recorded in Plat Book G at Page 274, and being further shown as Lot No. 12 on a more recent plat of Property of Marion Tillman Harry, dated August August 4, 1973, prepared by R. B. Bruce, RLS, and described as follows, to-wit:

Beginning at an iron pin on the Eastern side of Briarcliff Drive (formerly Central Street), 180 feet from the Northeast corner of West-yiew Road and Briarcliff Drive, and running thence with Briarcliff Drive, N 43-45 E 60 feet to an iron pin, corner of Lot 11; thence with the line of said Lot, S 36-38 E 199 feet to a pin on the Western side of a 15½ foot alley; thence with the Western side of said alley, S 42-35 W 53 feet to a pin in the center of original Lot No. 13; thence N 38-17 W 199 feet to the point of beginning.

The estimated monthly premium for the first nine years will be 02% of the original amount of the loan.
