

MORTGAGE OF REAL ESTATE

To All Whom These Presents May Concern:

WHEREAS, said note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty days, or if there shall be any failure to comply with and abide by any By-Laws or the Charter of the Mortgagee, or any stipulations set out in this mortgage, the whole amount due thereunder shall, at the option of the holder thereof, become immediately due and payable, and said holder shall have the right to institute any proceedings upon said note and any collaterals given to secure same, for the purpose of collecting said principal due, and interest, with costs and expenses for proceedings; and

WHEREAS, the Mortgagor may hereafter become indebted to the Mortgagee for such further sums as may be advanced to the Mortgagor's account for the payment of taxes, insurance premiums, repairs, or for any other purpose,

NOW, KNOW ALL MEN. That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagoe to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the scaling of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, hing and being in the State of South Carolina, County of Greenville, on the southwestern side of Carol Drive, and being known and designated as Lot 8 of Haselwood, Section No. I, as shown on a plat thereof prepared by Dalton & Neves, Engineers, dated June, 1973, recorded in the R.M.C. Office for Greenville County in Plat Book 4X at page 73, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southwestern side of Carol Drive at the country front corner of Lots 8 and 9, and running thence with the line of Clot 9, S. 36-34 W., 100 feet to an iron pin; thence continuing with the Cline of Lot 9, S. 62-00 W., 126.6 feet to an iron pin at the joint rear corner of Lots 8 and 9 on the line of Lot 10; thence with the line of Lot 10, N. 50-30 W., 160 feet to an iron pin at the joint rear corner of Lots 8 and 7; thence with the line of Lot 7, N. 31-54 E., 206.9 feet to an iron pin at the joint front corner of Lots 8 and 7 on the southwestern side of Carol Drive; thence with the southwestern side of Carol Drive, \$. 53-26 B., 231 feet to the point of beginning.

The above described property is a portion of the property heretofore conveyed to the mortgagor by deed from Devenwood Land Company, a partnership, executed November 30, 1977, and recorded December 1, 1977, and Deed Book 1069 at page 446.
