"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville

ALL that certain piece, parcel or tract of land situate, lying and being on the eastern side of Walker Road in the County of Greenville, State of South Carolina, containing 4.0 acres and having the following mests and bounds according to plat entitled \*Property of Mildred S. Center\* dated May 15, 1975, revised October 19, 1977 by Campbell and Clarkson Surveyors, Inc.:

BEGINNING at a point in the center of Walker Road, which point is located approximately 592.17 feet north of the intersection of Jackson Grove Road and Walker Road and running thence with the center line of Walker Road N. 14-02 W. 180.3 feet to a point; thence N. 13-27 W. 77 feet to a point; thence leaving Walker Road and running S. 88-34 E. 741.1 feet to a point; thence S. 305 W. 250 feet to a point; thence N. 88-25 W. 666.07 feet to the point of beginning and being a portion of the property conveyed to the grantor herein by deed of J. THIS conveyance is made subject to the following covenants and restrictions which shall be for the benefit of other adjoining property now owned by the grantor herein, her heirs and assigns and shall be deemed to be covenants running with the land; (a) This property shall be used solely and exclusively for single family residential dwellings and no mobile home, trailer or other structure of a temporary character shall be placed thereon; (b) No residence shall be erected on this property with a heated ground floor area of less than 1600 square feet, exclusive of porches and garages.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its heirs, soor isons and assigns, forever.

The Mortgagor covenants that it is lawfully serzed of the premises hereinabove described in ree simple absolute, that it has good right and is lawfully authorized to sell, convey or encomber the same, and that the premises are free and clear of all liens and encumbrances except as provided herein.
