We, Harry Lee Foreman and Delores F. Foreman

SEND GREETING:

WHEREAS, we the said Harry Lee Foreman and Delores F. Foreman

in and by our certain promissory note in writing of even date with these Presents, are well and truly indebted unto the CITIZENS BUILDING AND LOAN ASSOCIATION, Greer, S. C., in the full and just sum of Three Thousand and No/100 ----- (\$ 3,000.00 ) Dollars,

with interest from the date hereof at the rate of Nine per cent ( 9 %) per annum, unpaid interest to bear interest at the same rate, to be repaid in installments of Fifty Four and 08/100-----

KNOW ALL MEN BY THESE PRESENTS, That we the said Harry Lee Foreman and Delores F. Foreman, in consideration of the said debt and sums of money aforesaid, and for the better securing the payment thereof to the said CITIZENS BUILDING AND LOAN ASSOCIATION, Greer, S. C., according to the terms of the said note, and also in consideration of the further sum of Three (\$3.00) Dollars to us the said mortgagor, in hand well and truly paid by the said mortgagee, at and before the sealing and delivery of these Presents (receipt of which is hereby acknowledged), have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said CITIZENS BUILDING AND LOAN ASSOCIATION, Greer, S. C. on the East side of Pine Street and being shown and designated as lot number TWELVE (12) on plat of property made for Mrs. L. W. Cunningham by H. S. Brockman, surveyor, Aug. 27, 1928 and recorded in plat book "C" page 212A, Greenville County R.M.C. Office and having the following courses and distances to wit:

Beginning on the east side of pine St. at the joint front corner of lots 11 and 12 and running thence with common line of said lots N. 87-10 E., 125 feet to cemetery; thence with cemetery line, N. 2-50 E., 81.4 feet; thence S. 89-00 W., 125.7 feet to Pine Street; thence with East side of Pine St., S. 2-50 W., 77.2 feet to the beginning corner.
