"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, at the southeastern corner of the intersection of Creighton Street and Ardmore Drive and being known and designated as lot 18 as shown on a plat of Section No. 3, Colonial Hills, recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book BBB at Page 91 and having, according to said plat, the following metes and bounds:

BEGINNING at a point on the southern edge of Ardmore Drive at a

joint corner of lots 18 and 142 and running thence along a line of lot 142 S. 9-45 W. 125.9 feet to a point; thence along a line of lot 17 N. 80-15 W. 160.0 feet to a point on the southeastern side of Creighton Street; thence along the southeastern edge of Creighton Street N. 9-45 E. 95.0 feet to a point; thence with the curve of the southeastern corner of the intersection of Creighton Street and Ardmore Drive, the chord of which is N. 54-29 E. 35.6 feet to a point on the southern edge of Ardmore Drive; thence continuing along the Southern edge of Ardmore Drive S. 86-33 E. 43.9 feet to the beginning corner.
