NOW. KNOW ALL MEN, that the mortgagoris) in consideration of the said debt, and for the better securing the payment thereof, according to the conditions of the said Note; which with all its provisions is hereby made a part hereof; and also in consideration of Three Dollars to the said mortgagor in hand well and truly paid, by the said mortgage, at and before the sealing and delivery of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said mortgage, its (his) heirs, successors and assigns forever, the following described real estate:

All that certain piece, parcel or lot of land on the East side of 4th Avenue, in Judson Mills No. 1 Village in the County of Greenville, State of South Carolina, being known and designated as Lot No. 23, as shown on a plat of Section I, of Judson Mills Village made by Dalton & Neves, Engineers, in August 1939, which plat is recorded in the RMC Office for Greenville County in Plat Book K, at pages 11 and 12, and having according to said plat, the following metes and bounds, to-wit: BEGINNING at an iron pin on the East side of 4th Avenue, 143 feet North of the Northeast corner of the intersection of 4th Avenue and Heatherly Drive, and running thence with 4th Avenue, N. 4-30 E. 70 feet to an iron pipe, joint front corner of Lots No. 23 and 24; thence with the line of Lot No. 24, S. 85-30 E. 88.5 feet to an iron pin; joint rear corner of Lots. No. 6 and 7; thence with the line of Lot No. 7, S. 4-30 W. 70 feet to an iron pipe, joint corner of Lots No. 7, 8, 22 and 23; thence with line of Lot No. 22; N. 85-30 W. 88.5 feet to the beginning corner; the above Grantors and Grantee are heirs at law of Maude K. Godfrey who died intestate in 1969, according to Probate records in Apt. 1342, File 10, Probate Court for Greenville County, S. C. It is the intention of the Grantors herein to convey whatever their interest might be in the above described property. Being the same property conveyed to Wm. N. Godfrey by deed of Charles S. Godfrey, Annie Lou Cheek, and James W. Godfrey dated 2/28/75, rec. 4/24/75 and by deed of Etalia Graham and Osborne C. Godfrey dated 4/11/75 and rec. 4/24/75.

This is the identical property conveyed to Josie P. Godfrey by will of William N. Godfrey on 7/10/75, who died 2/26/76, and recorded in Apt. 1418, File 30, Probate Records for Greenville County, S. C.

TOGETHER with all and singular the rights, members, hereditaments and appurtenances to the said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD, all and singular the said Premises unto the said mortgagee, its (his) successors, hetrs and assigns forever-

AND I (we) do hereby bind my (our) self and my (our) heirs, executors and administrators, to procure or execute any further necessary assurances of title to the said premises, the title to which is unencumbered, and also to warrant and torever defend all and singular the said Premises unto the said mortgagee its (his) heirs, successors and assigns, from and against all persons lawfully claiming, or to claim the same or any part thereof.

AND IT IS AGREED, by and between the parties hereto, that the said mortgagor(s) his (their) heirs, executors, or administrators, shall keep the buildings on said premises, insured against loss or damage by fire, for the benefit of the said mortgages, for an amount not less than the unpaid balance on the said Note in such company as shall be approved by the said mortgages, and in default thereof, the said mortgages, its (his) heirs, successors or assigns, may effect such insurance and reimburse themselves under this mortgage for the expense thereof, with interest thereon, from the date of its payment. And it is further agreed that the said mortgages its (his) heirs, successors or assigns shall be entitled to receive from the insurance moneys to be paid, a sum equal to the amount of the debt secured by this mortgage.

AND IT IS AGREED, by and between the said parties, that if the said mortgogor(s), his (their) heirs, executors, administrators or assigns, shall fall to pay all taxes and assessments upon the said premises when the same shall first become payable, then the said mortgagee, its (his) heirs, successors or assigns, may cause the same to be paid, together with all penalties and costs incurred thereon, and reimburse themselves under this mortgage for the sums so paid, with interest thereon, from the dates of such payments.

AND IT IS AGREED, by and between the said parties, that upon any default being made in the payment of the said Note, when the same shall become payable, or in any other of the provisions of this mortgage, that then the entire amount of the debt secured, or intended to be secured hereby, shall forthwith become due, at the option of the said mortgagee, its (his) heirs, successors or assigns, although the period for the payment of the said debt may not then have expired.

AND IT IS FURTHER AGREED, by and between the said parties, that should legal proceedings be instituted for the foreclosure of this mortgage, or for any purpose involving this mortgage, or should the debt hereby secured be placed in the hands of an attorney at law for collection, by suit or otherwise, that all costs and expenses incurred by the mortgagee, its (his) heirs, successors or assigns, including a reasonable counsel fee (of not less than ten per cent of the amount involved) shall thereupon become due and payable as a part of the debt secured hereby, and may be recovered and collected hereunder.

PROVIDED, ALWAYS, and it is the true intent and meaning of the parties to these Presents, that when the said mortgagor, his (their) heirs, executors or administrators shall pay, or cause to be paid unto the said mortgages, its (his) heirs, successors or assigns, the said debt, with the interest thereon, if any shall be due, and also all sums of money paid by the said mortgages, his (their) heirs, successors, or assigns, according to the conditions and agreements of the said note, and of this mortgage and shall perform all the obligations according to the true intent and meaning of the said note and mortgage, then this Deed of Bargain and Sale shall cease, determine and be void, otherwise it shall remark to first force and visiting remain in full force and virtue,

AND IT IS LASTLY AGREED, by and between the said parties, that the said mortgagor may hold and enjoy the said premises until default of
