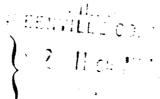

Timmons, Jr., according to plat recorded in the R.M.C. Office for Greenville County, in Plat Book BBB at Page 15 and having the following metes and bounds, to wit:

BEGINNING at a point on the northern side of Bethel Drive at the joint front corner of Lots 5 & 6, and running thence with the northern side of Bethel Drive, N 47-51 W, 117.2 ft. to a point at the northeastern intersection of Bethel Drive with Fargo Street, (the chord of which is N 2-51 W) 35.35 ft. to a point; thence with the eastern side of Fargo Street N 42-09 E, 77 ft. to a point; thence N 45- 04 E, 73.1 ft. to a point at the joint front corner of Lots 6 & 7; thence S 47-51 E, 138.2 ft.to a point at the joint rear corner of Lots 5 & 6; thence S 42-09 W, 175 ft. to the point of beginning.
