being in the State of South Carolina, County of Greenville, in the City of Greenville, being known and designated as Lots 12, 13 and the southern one-half of Lot 14, Block A, on Plat of Stone Estates, which plat is recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book G, at page 292, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the western side of Druid Street, said pin being 275 feet north of intersection of Druid Street and Reid Street and the joint front corner of Lots 11 and 12 of Block A; and running thence N. 78-38 W. 125 feet to an iron pin; thence N. 11-22 E. 62.5 feet to a stake on the center of rear line of Lot 14; thence through the center of Lot 14 S. 78-38 E. 125 feet to a stake on the western side of Druid Street; thence along the western side of Druid Street S. 11-22 W. 62.5 feet to an iron pin, the point of beginning.
