shall notify the lessor of any such default, and the lessor shall have failed to completely cure such default within thirty days of receipt of said notice. The Mortgagor herein, its successors or assigns, does hereby appoint the noteholder as its agent for the performance of any obligation of said Mortgagor in any lease affecting the mortgaged premises, provided, however, that any such acts by said noteholder shall be solely at its option and election and for purposes of protecting its security interest in the mortgaged premises. This paragraph shall apply to all leases affecting the property described herein.
