All that piece, parcel or lot of land lying the State of South Carolina, County of Greenville, shown as Lot 142 on plat of Dove Tree Subdivision, recorded in Plat Book 4X at pages 21, 22 and 23 and having such courses and distances as will appear by reference to said plat, as follows: beginning at the joint front corner of lots 142 and 143 and running with the joint line of said lots N 50-29 E 159.1 feet to the joint rear corner of said lots; thence with the joint rear lines of lots 142 and 124 S 17-30 E 161 feet to an iron pin, thence S 52-46 W 137.1 feet to an iron pin, thence S 41-57 E 107 feet to a point on Peppertree Court thence with the curve of Peppertree Court N 33-56 E 25 feet to a point, thence continuing along Peppertree Court N 7-01 W 35 feet to the point of beginning, being the same property conveyed to the mortgagor by deed of Raymond A. "In addition to and together with the monthly payments of principal and interest under the terms of the Note secured hereby, the mortgagor promises to pay to the mortgagee a monthly premium necessary to carry private mortgage guaranty insurance until the principal balance reaches 80% of the original sales price or appraisal, whichever is less. The estimated monthly premium for the first nine years will be .02% of the original amount of the loan. The estimated monthly premium for each year thereafter will be .01% of the original principal balance of this loan. The mortgagee may advance this premium and collect it as part of the debt secured by the mortgage if the mortgagor fails to pay it."
