ALL that piece, parcel or lot of land situate, lying and being on the northern side of Saratoga Drive near the City of Greenville, in the County of Greenville, State of South Carolina, known and designated as Lot No. 25 of a Subdivision known as Canebrake I, plat of which is recorded in the RMC Office for Greenville County, South Carolina in Plat Book 5-D at Page 96, and according to said plat, has the following metes and bounds, to-wit:
