STATE OF SOUTH CAROLINA COUNTY OF GREENVILLE WHEREAS, William J. Holloway and Betty J. Holloway Wife
hereinafter called the Mortgagor, are well and gruly indebted to JIM WALTER HOMES, Inc., hereinafter called the Mortgagee, in the full and just sum of Farty Bul. I Will Rand Light Hundred Thirty Livo and Molloo evidenced by a certain promissory pote in writing of even date herewith, which note is made a part hereof and herein incorporated by reference, monthly installments of Lung Hundred Thirty Funt + 49/190 Dollars (\$ 232 40) each, the 57/ day of Alceluker first installment being due and payable on or before the with interest at the rate of six per cent (6%) per annum from the date of maturity of said note until paid, and said Morrgagor having further promised and agreed to pay ten per cent (10%) of the whole amount due for attorney's fee, if said note be collected by attorney or through legal proceedings of any kind, reference being thereunto had will more fully appear.

NOW, KNOW ALL MEN. That the said Mortgagor, in consideration of the said debt and sum of money aforesaid, and for better securing the payment thereof, according to the terms and tenor of said note, and also in consideration of THREE (\$3.00) DOLLARS to them in hand well and truly paid at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Mortgagee, all that tract or lot of land lying, being and situated in GREENVILLE

County, State of South Carolina and described as follows, to-wit: All that piece, parcel or lot of land in Greenville County, State of South Carolina, O'Neal Township, located on the Northern side of Ponder Road, and being shown on Plat of property made for William J.& Betty J. Hollaway by Gould & Assoc., dated 5-8-78 to be Recorded herewith and having the following metes and bounds, to wit: (Shown as Lot No. 1 on said plat.) bk 6Q pg 4

Beginning in center of said road, which is the Southeast corner of 4.00 acre lot as shown on plat Recorded in Plat Book 5U Page 48, and running thence N-79-27 W 126.1 feet along center of said road; thence N-7-57 E 19 feet to pin on North side of road, corner of other property of the within grantors; thence on the same course for a total distance of 355.6 feet to iron pin; thence S-79-27 E 119.2 feet to pin; thence S-5-50 W 355.96 feet to center of said road (pin set back on line at 19 feet) and the beginning corner and containing one (1) acre, more or less.

Above said one (1) acre is the identical property conveyed, June 11, 1978, by Deed of James A. St. John and Helen R. St. John to William J. Hollaway and Betty J. Hollaway; said Deed being Recorded in the RMC Office of Greenville County South Carolina in Deed Book 1081 at Page 277.

TOGETHER WITH all and singular the ways, easements, riparian and other rights, and all tenements, hereditaments and appurtenances thereunto belonging or in anywise appertaining, and all buildings, structures and other improvements now on said land or that hereafter may be erected or placed thereon, and all fixtures attached thereto and all rents, income, issues and profits accruing and to accrue therefrom.

TO HAVE AND TO HOLD the above described property unto Mortgagee, his heirs, successors, and assigns forever.

Mortgagor hereby covenants with Mortgagee that Mortgagor is indeteasibly seized with the absolute and fee simple title to said property; that Mortgagor has full power and lawful authority to sell, convey, assign, transfer and mortgage the same; that it shall be lawful for Mortgagee at any time hereafter peaceably and quietly to enter upon, have, hold and enjoy said property and every part thereof; that said property is free and discharged from all liens, encumbrances and claims of every kind, including all taxes and assessments; that Mortgagot will, at his own expense, make such other and further instruments and assurances to vest absolute and fee simple title to said property in Mortgagee that may be requested by Mortgagee; and that Mortgagor will, and his heirs, legal representatives and successors shall, warrant and defend the title to said property unto Mortgagee against the lawful claims and demands of all persons whomsoever.

PROVIDED ALWAYS, and these presents are upon these express conditions, that if the said Mortgagor shall promptly, well and truly pay to the Mortgagee the said debt or sum of money aforesaid, according to the true intent and tenor of said note, and until full payment thereof, or any extensions or renewals thereof in whole or in part, and payment of all other indebtedness or liability that may become due and owing hereunder and secured hereby, shall faithfully and promptly comply with and perform each and every other covenant and provision herein on the part of the Mortgagor to be complied with and performed, then this deed of bareain and sale shall cease, determine, and be utterly void; otherwise to remain in full force and virrue.

And Mortgagor hereby covenants as follows

To keep the buildings, structures and other improvements now or hereafter erected or placed on the premises insured in an amount nor less than the principal amount of the note aforesaid against all loss or damage by fire, windstorm, tornado and water damage, as may be required by the Mortgagee, with loss, if any payable to the Mortgagee as his interest may appear; to deposit with the Mortgagee policies with standard mortgagee clause, without contribution, evidencing such insurance; to keep said premises and all improvements thereon in first class condition and tepair. In case of loss, Morreagee in hereby authorized to adjust and settle any claim under any such policy and Mortgagee is authorized to collect and receipt for any such insurance money and to apply the same, at Morreagee's option, in reduction of the indebtedness hereby secured, whether due or nor, or to allow Mortgagor to use such insurance money, or any part thereof, in repairing the damage or restoring the improvements or other property without affecting the lien heleof for the full amount secured hereby.

It is further covenanted that Mortalizee may (but shall not be obligated so to do) advance moneys that should have been paid by Mortalizee bereunder in order to protect the lien or security hereof, and Morteacor agrees without demand to forthwith repay such moneys, which amount shall hear interest from the date so advanced until paid at the rate of six per cent (6%) per annum and shall be considered as so much additional adebiedness secured hereby; but no payment by Mortgacee of any such moneys shall be deemed a waiver of Mortgagee's right to declare the D'incipal sum due hereunder by reason of the default or violation of Mortgagor in any of his covenants hereunder.

Mortgagor further covenants that granting any extension or extensions of the time payment of any part or all of the total indebtedness or liability secured hereby, or taking other or a ditional security for payment thereof, shall not affect this mortgage or the rights of Mortgagee here-Inder, or operate as a release from any liability upon any part of the indeb edness hereby secured, under any covenant herein contained
