The Mortgagor further covenants and agrees as follows:

WITNESS the Mortgagor's hand and seal this

- (1) That this mortgage shall secure the Mortgagee for such further sums as may be advanced hereafter, at the option of the Mortgagee, tor the payment of taxes, insurance premiums, public assessments, repairs or other purposes pursuant to the convenants herein.
