TOGETHER with all and strictular the rights, members, hereditaments and appurtenances to the said premises belonging, or in anywise incident or acceptaining
TO HAVE AND TO HOLD, all and singular the said Premises unto the said mortgages, its (his) successors, heirs and assigns forever.
AND I (we) do hereby bind my (c.r.) self and my (our) heirs, executors and administrators, to produce or execute any further necessary assurances of title to the said premises, the title to which is unencumbered, and also to warrant and forever defend all and simplar the said Premises who the said mortgadee its (his) heirs, successors and assigns, from and against all persons lawfully claiming, or to a law the name or any part thereof.
