

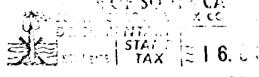

BEGINNING at an iron pin on the southwestern side of Saratoga Drive, joint front corner of Lots Nos. 20 and 21; and running thence with the joint line of said lots, S. 46-53 W., 159.61 feet to an iron pin; thence N. 38-27 W., 62 feet to an iron pin, joint rear corner of Lots Nos. 21 and 22; thence with the joint line of said lots, N. 32-03 E., 143.87 feet to an iron pin on the southwestern side of Saratoga Drive; thence with said Drive, S. 53-30 E., 47.03 feet to an iron pin; thence continuing with Saratoga Drive, S. 50-45 E., an arc distance of 52.86 feet to the joint front corner of Lots Nos. 20 and 21, the point of BEGINNING.
