

C., according to the terms of the said note, and also in consideration of the further sum of Three (\$3.00) Dollars to us the said mortgagor... in hand well and truly paid by the said mortgagee, at and before the sealing and delivery of these Presents (receipt of which is hereby acknowledged), have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said Citizens Building and Loan Association, Greer, S. C., its successors and assigns:

as a part thereof, if the same be placed with an attorney for collection, or if said debt, or any part thereof, be collected

That certain lot, parcel or tract of land, with all improvements now constructed thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina. County of Greenville, lying between Pelham Street and South Trade Street in the City of Greer, adjoining property now owned by the said Church of God, being Lots Nos. 3, 4, 5 and 6 on a plat of Mrs. I. E. Green's land, replatted for J. L. Grimshawe, recorded inPlat Book "G", page 38, R. M. C. Office for said County, and being the same property conveyed to Homer Blmore by deed of Ada G. Elmore, recorded in Deed Book 396, page 156, R. M. C. Office for said County.

This is the same conveyed to us by Homer Elmore by deed dated August 7, 1954 recorded in Deed Book 508 page 507.

ALSO: All that piece, parcel or lot of land in Chick Springs Township, Greenville County, State of South Carolina, in the City of Greer, lying on the east side of Pelham Street and on the west side of Trade Street, being triangular in shape and lying in the intersection of said two streets, having the following courses and distances: BEGINNING on an iron pin on the east side of Pelham Street, the southwestern corner of the lot, and runs thence S. 67 E. 75 feet to an iron pin on the west side of Trade Street; thence with Trade Street N. 15 3/4 W. 96.4 feet to the intersection of aforesaid streets; thence with the east side of Pelham Street S. 41 W. 73 feet to the beginning corner.
