(4) That it will pay, when due, all taxes, public assessments, and other governmental or municipal charges, fines or other impositions against comply with all governmental and municipal laws and regulations affecting the mortgaged premises.

(7) That the Mortgagor shall hold and empty the premises above conveyed until there is a detailt under this mortgage or in the note secured hereby. It is the true meaning of this instrument that if the Mortgagor shall fully perform all the terms, conditions, and covenants of the mortgage, and of the note secured hereby, that then this mortgage shall be utterly null and void; otherwise to remain in full force and virtue.

(8) That the covenants herein contained shall bind, and the benefits and advantages shall innie to, the respective helps, executors, administrators, successors and assigns, of the parties hereto. Whenever used, the singular shall included the plurid, the plurid the singular, and the use of any gender shall be applicable to all genders.
