with interest thereon from _____ date _____ at the rate of 10% per centum per annum, to be paid as stated above



NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, City of Greenville, on the southside of Choice Avenue (now University Ridge), and having the following notes and bounds, to-wit:

BEGINNING at a stake on Choice Avenue, now University Ridge, and corner of Lot D and thence with said street N 89 1/2 W 59 3/4 feet to a stake on corner of lot F; thence with line of lots F and K S 1/2 W 200 feet to a 20-foot alley; thence with said alley N 89 1/2 W 59 3/4 feet to a stake on lot H; thence with aforesaid lots H & D, S 1/2 W 200 feet to the beginning corner; being lots H and I, and more particularly described on a map representing a subdivision of the Carson property made and surveyed by J.R. Southern, D.S., April 21, 1969.

Together with all and singular rights, members, hereditaments, and appurtenances to the same belonging in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures now or hereafter attached, connected, or fitted thereto in any manner, it being the intention of the parties hereto that all fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.

The Mortgagor covenants that it is lawfully seized of the premises hereinabove described in fee simple absolute, that it has good right and is lawfully authorized to sell, convey or encumber the same, and that the premises are free and clear of all liens and encumbrances except as provided herein. The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagee forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.
