

MORTGAGE

THIS MORTGAGE is made this 17th day of January 19.79, between the Mortgagor, Billy R. Chandler Savings and Loan Association, a corporation organized and existing under the laws of the United States of America, whose address is 301 College Street, Greenville, South Carolina therein "Lender").

WHEREAS, Borrower is indebted to Lender in the principal sum of Ninety Thousand and and interest, with the balance of the indebtedness, if not sooner paid, due and payable on September 1, 2009

TO SECURE to Lender (a) the repayment of the indebtedness evidenced by the Note, with interest thereon, the payment of all other sums, with interest thereon, advanced in accordance herewith to protect the security of this Mortgage, and the performance of the covenants and agreements of Borrower herein contained, and (b) the repayment of any future advances, with interest thereon, made to Borrower by Lender pursuant to paragraph 21 hereof (herein "Future Advances"). Borrower does hereby mortgage. grant and convey to Lender and Lender's successors and assigns the following described property located in the County of _______, State of South Carolina:

ALL that piece, parcel or lot of land, situate, lying and being in the City of Greenville, County of Greenville, State of South Carolina, being shown and designated as Lot No. 56 of a subdivision known as STONE LAKE HEIGHTS, Section III, on plat thereof prepared by Piedmont Engineering Service, dated October 1, 1958, revised May 26, 1961, and recorded in the RMC Office for Greenville County in Plat Book QQ at Page 96, and also being shown on a plat entitled "Property of Billy R. Chandler", prepared by Carolina Surveying Company, recorded in the FMC Office for Greenville County in Plat Book 2 2 at Page 2 and having, according to the more recent plat, the following metes and bounds, to-wit:

BEGINNING at an aron pin on the western side of Stone Lake Drive, joint front corner of Lots 10 and 50 and running thence N.76-30 W. 269.0 feet to an aron pan; running thence N.30-56 E. 125.8 feet to an iron pin; running thence S.76-30 B. 231.3 feet to an iron pin on the western side of Stone Dake Driver running thence with the western side of Stone lake brive, \$.13-3. W. 125 feet to the point of Legithing.
