THIS MORTGAGE is made this 19th day of January 1979, between the Mortgagor, **Bobby Joe Jones Builders, Inc.**, a corporation organized and existing under the laws of the State of South Carolina, whose address is 203 State Park Road, Travelers Rest, S. C. 29690, and the Mortgee, **POINSETT FEDERAL SAVINGS AND LOAN ASSOCIATION of Travelers Rest**, a corporation organized and existing under the laws of the State of South Carolina, whose address is 203 State Park Road, Travelers Rest, S. C. 29690 (herein "Lender").


Whereas, Borrower is indebted to Lender in the principal sum of **Thirty Four Thousand Eight Hundred and no/100----- Dollars**, which indebtedness is evidenced by Borrower's note dated **January 19, 1979**, (herein "Note"), providing for monthly installments of principal and interest, with the balance of the indebtedness, if not sooner paid due and payable on **June 1, 1985**.

To SECURE to Lender (a) the repayment of the indebtedness evidenced by the Note, with interest thereon, the payment of all other sums, with interest thereon, advanced in accordance herewith to protect the security of this Mortgage, and the performance of the covenants and agreements of Borrower herein contained, and (b) the repayment of any future advances, with interest thereon, made to Borrower by Lender pursuant to paragraph 21 hereof (herein "Future Advances"), Borrower does hereby mortgage, grant and convey to Lender and Lender's successors and assigns the following described property located in the County of Greenville, State of South Carolina:

All that piece, parcel or lot of land lying in the State of South Carolina, County of Greenville, shown as Lot 18 on plat of Stratford, Section II, Revised, recorded in Plat Book 59 at page 90 and having the following courses and distances:

BEGINNING at an iron pin on LaJuan Drive, joint front corner of Lots 18 and 19, and running thence with the joint line of said lots, S. 83-10 E. 173.77 feet to an iron pin, joint rear corner of said lots; thence along the rear line of Lot 18, S. 15-49 W. 60 feet to an iron pin, joint rear corner of Lots 17 and 18; thence with the joint line of said lots, N. 82-52 E. 184.54 feet to an iron pin on LaJuan Drive; thence S. 8-26 E. 63.1 and S. 6-53 E. 16.9 feet to an iron pin, the point of beginning.

Borrower covenants that Borrower is lawfully seized of the estate hereby conveyed and has the right to mortgage, grant and convey the Property, that the Property is unencumbered, and that Borrower will warrant and defend generally the title to the Property against all claims and demands, subject to any declarations, easements or restrictions listed in a schedule of Acquisitions to coverage in any title insurance policy insuring Lender's interest in the Property.
