NOW, KNOW ALL MEN. That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagor at any time for advances made to or for his account by the Mortgagor, and also in consideration of the further sum of Three Dollars (\$300) to the Mortgagor in hand well and truly paid by the Mortgagor at and before the scaling and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville.

All that certain piece, parcel or lot of land, with the buildings and improvements thereon, lying and bein on the easterly side of Pine Forest Drive, in the City of Greenville, SC and being designated as a portion of lot 8 all of lot 9, and the rear porions of lots 10,11,12 and 13, Block A. on plat of Forest hill as recorded in the RMC office for Greenville County, SC in plat book D, page 206, and having according to a ore recent survey entitled Property of William M. Madde," made by R. W. Dalton, dated May 9, 1962; the following metes and bounds to wit:

BEGINNING at an iron pin on the easterly side of Pine Forest Drive, which pin is located 195.6 feet from the southeasterly corner of the intersection of Pine Forest Drive and Cleveland Street and running thence along the easterly side of said Drive S 5-38 % 90 feet to an iron pin in the front line of Lot No. 8 thence through lot No. 8 S 87-0 E 183 feet to an iron pin; thence N 3-39 E 90 feet to an iron pin in the easterly line of Lot 13; thence on a line through Lots 13, 12,11, and 10, N 87-0 N 180 feet to an iron pin, the point of beginning.

For restrictions applicable to this subdivision see deed Book 286, page 298 and 399.

This is the same property conveyed by deed of William M. Midden dated 1-17-66 recorded 1-18-66 in volume 700 at page 274.

Together with all and singular the rights, members, bereditaments, and appurtenences to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had thereform, and including all heating, plumbing, and lighting fixtures and not other expurpment or fixtures row or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fix there and a minute at the state of the manner.






