WITNESSETH:

THAT WHEREAS, H. E. Freeman Construction Company, Inc.,
is indebted to Mortgagee in the maximum principal sum of Twenty-five Thousand and no/100-----
Dollars (\$25,000.00), which indebtedness is
evidenced by the Note of H. E. Freeman Construction Company, Inc. of even
date herewith, said principal together with interest thereon being payable as provided for in said Note, the final maturity of
which is January 20, 1986 after the date hereof, the terms of said Note and any agreement modifying it
are incorporated herein by reference.

NOW THEREFORE, KNOW ALL MEN BY THESE PRESENTS that the said Mortgagor, for and in consideration of the
aforesaid indebtedness and in order to secure the payment thereof together with any renewals or extensions or modifications
thereof upon the same or different terms or at the same or different rate of interest and also to secure in accordance with
Section 29-3-50, as amended, Code of Laws of South Carolina (1976), in all future advances and readvances that may
subsequently be made to Mortgagor by Mortgagee evidenced by the aforesaid Note, or by other promissory notes, and all
renewals and extensions thereof, and in all other indebtedness of Mortgagor to Mortgagee, now or hereafter existing, whether
direct or indirect, the maximum amount of all indebtedness outstanding at any one time secured hereby not to exceed
\$25,000.00 plus interest thereon, all charges and expenses of collection incurred by Mortgagee
including court costs and reasonable attorneys' fees, has granted, bargained, sold, released and by these presents does grant,
bargain, sell and release unto the Mortgagee, its successors and assigns, the following described property:

ALL That piece, parcel or lot of land situate, lying and being on the
western side of Miller Road in the County of Greenville, State of South
Carolina, containing 1.404 acres, being described more particularly, ac-
cording to plat of property of H. E. Freeman Construction Company, pre-
pared by Freeland and Associates, dated October 13, 1978, recorded in
Plat Book 6-W at Page 42, to-wit:

BEGINNING At a railroad spike in the center of Miller Road, said spike
being located 794.0 feet, more or less, in a northwesterly direction from
the intersection of said road and Hines-Smith Road, and running thence
along the common line of the within-described property and property of
Ella Thornton, S. 86-16 W. 197.18 feet to an iron pin; thence N. 07-15 E.
631.87 feet to a railroad spike in the center of Miller Road; thence along
the center line of said road, S. 10-47 E. 625.03 feet to a spike, the point
of beginning.
