LOAN ASSUMPTION and MODIFICATION AGREEMENT

The Purchasers do hereby assume and agree to pay said indebtedness endenced by the aforementioned note and mortgage and to perform all obligations and comply with all terms, conditions and covenants provided therein. It is specifically understood and agreed by and between all parties that a consideration for the association's consent to the transfer of title is that the collected interest rate on the remaining indebtedness of \$\frac{64.754.69}{2.54.69}\$ shall be, from this date forward, \$\frac{92.55}{2.55}\$ per annum, the rate stated in the aforementioned note notwithstanding, and that the monthly installment of
