E. Hollingsworth and Hazel Hollingsworth to the Pelzer-Williamston Bank, now a part of Southern Bank and Trust Company, by merger, dated August 12, 1966, and recorded in the R.M.C. This being the same tract of land conveyed to us by Mrs. Mae Cox Locke by deed of even date. ALSO all that other piece, parcel or tract of land in Grove Township, Greenville County, SC, containing two and three tenths (2 3/10) more or less adjoining lands of Mrs. Sunie Gambrell and others; for further description see plat made by J. Coke Smith, Surveyor, on March 30, 1944. This is the same tract of land conveyed to us by Mrs. Mae Cox Locke by deed of even date.

It is hereby expressly understood and agreed that this release shall not impair or affect the security and lien of said mortgage on the other lot of land described in such mortgage except as to the two lots of land hereinabove particularly described.
