(bereinafter referred to as Mortgagor) is well and truly indebted unto ROBERT M. HEAD and ELIZABETH W. HEAD-----

in twenty (20) equal semi-annual payments of principal and interest in the amount of \$999.44, the first such payment being due and payable six (6) months from the date hereof,

with interest thereon from date at the rate of 98 per centum per annum, to be paid: Semi-annually.

WHEREAS, the Mortgagor may be reafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

ALL that certain piece, parcel or tract of land, located, lying and being in the County of Greenville, State of South Carolina, near the Town of Highland, containing 10.2 acres, more or less, as shown on plat entitled "Survey for Alva Billy D. Gibson", dated February 15, 1979, prepared by W. R. Williams, Jr., recorded in the Greenville County R.M.C. Office in Plat Book

7-A at Page 15 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at a railroad spike in the center of the right-of-way of S.C. Highway 101 (said point being 2 miles, more or less, to the Town of Highland) and running thence along said right-of-way N. 21-40 W., 390.0 feet to a railroad spike in the center of the right-of-way of S.C. Highway 101; thence N. 58-54 E., 39.0 feet to an old iron pin in or near a Farm Road in the line of property now or formerly of Bates; thence S. 75-38 E., 1,533.4 feet to an old iron pin in or near a Farm Road in the line of property now or formerly of Dusenberry; thence along the line of property now or formerly of Dusenberry S. 6-36 E., 254.8 feet to an iron pin; thence along a new line through property of the Grantor N. 79-52 W., 1,426.6 feet to a railroad spike in the center of the right-of-way of S.C. Highway 101, the point and place of beginning.

Together with all and singular rights, members, herditaments, and appurtenances to the same belonging in any way incident or appertaining, and of all the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual flousehold furniture, be considered a part of the real estate.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its heirs, successors and assigns, forever.

The Mortgagor covenants that it is lawfully seized of the premises hereinabove described in fee simple absolute, that it has good right and is lawfully authorized to sell, convey or encumber the same, and that the premises are free and clear of all liens and encumbrances except as provided berein? The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagoe forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.

The Mortgagor further covenants and agrees as follows:

(1) That this mortgage shall secure the Mortgagee for such further sums as may be advanced hereafter, at the option of the Mortgagee, for the payment of taxes, insurance premiums, public assessments, repairs or other purposes pursuant to the covenants herein. This mortgage shall also secure the Mortgagee for any further loans, advances, readvances or credits that may be made hereafter to the Mortgager by the Mortgagee so long as the total indebtedness thus secured does not exceed the original amount shown on the face hereof. All sums so advanced shall bear interest at the same rate as the mortgage debt and shall be payable on demand of the Mortgagee unless otherwise provided in writing.

(2) That it will keep the improvements now existing or hereafter erected on the mortgaged property insured as may be required from time to timently the Mortgagee against loss by fire and any other hazards specified by Mortgagee, in an amount not less than the mortgage debt, or in such mounts as may be required by the Mortgagee, and in companies acceptable to it, and that all such policies and renewals thereof shall be held by the Mortgagee, and have attached thereto loss payable clauses in favor of, and in form acceptable to the Mortgagee, and that it will pay all prefiliums therefor when due; and that it does hereby assign to the Mortgagee the proceeds of any policy insuring the mortgaged premises and does hereby authorize each insurance company concerned to make payment for a loss directly to the Mortgagee, to the extent of the balance owing on the Mortgage debt, whether due or not.
