MORTGAGE OF REAL PROPERTY

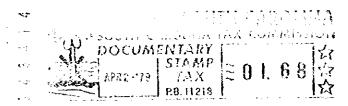

NOW, THEREFORE, in consideration of the aforesaid loan and the sum of Three Dollars (\$3.00) cash in hand paid to Mortgagor, the receipt of which is hereby acknowledged, Mortgagor hereby grants, sells, conveys, assigns and releases to Mortgagee, its successors and assigns, the following described premises located in Greenville County, South Carolina:

ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the East side of Jones Avenue, in the City of Greenville, known and designated as Lot 19, according to a plat of the property of Parrish and Gower, prepared by Dalton & Neves, Engineers, recorded in the R.M.C. Office for Greenville County in Plat Book G, at Page 197, and having the following metes and bounds, to-wit:
