\$102.56 per month including principal and interest computed at the

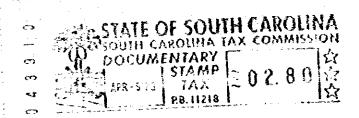

M. Furman, Jr., Engineer, recorded in Plat Book II at page 20 in the RMC Office for Greenville County and having according to said plat the following metes and bounds, to-wit:
