BEGINNING at an iron pin on the northeastern side of Dargan Avenue, said iron pin being one hundred (100) feet southeast of the intersection of Florida Avenue, Extension and Dargan Avenue, the joint front corner of Lots No. 19 and 20 and running thence with the line of Lot 20 N. 75-47 E. 200 feet to an iron pin; thence S. 14-13 E., 80 feet to an iron pin; thence with line of Lot 18 S. 75-47 W., 200 feet to an iron pin on Dargan Avenue, thence with the said Dargan Avenue, N. 14-13 W., 80 feet to the point of beginning.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its heirs, successors and assigns, forever.

The Mortgagor covenants that it is lawfully seized of the premises hereinabove described in fee simple absolute, that it has good right and is Hawfully authorized to sell, convey or encumber the same, and that the premises are free and clear of all liens and encumbrances except as provided Pierein. The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagee forever, from who against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.

The Mortgagor further covenants and agrees as follows:
