To Secure to Lender (a) the repayment of the indebtedness evidenced by the Note, with interest thereon, the payment of all other sums, with interest thereon, advanced in accordance herewith to protect the security of this Mortgage, and the performance of the covenants and agreements of Borrower herein contained, and (b) the repayment of any future advances, with interest thereon, made to Borrower by Lender pursuant to paragraph 21 hereof (herein "Future Advances"), Borrower does hereby mortgage, grant and convey to Lender and Lender's successors and assigns the following described property located in the County of Greenville....., State of South Carolina:

ALL that certain piece, parcel or lot of land, situate, lying and being on the southern side of Pemberton Drive, near the City of Greenville, Paris Nountain Township, Greenville County, South Carolina, being known and designated as Lot 7, Montroyal Hills, as shown on plat prepared by Piedmont Engineering Service, dated August 19, 1957, recorded in the RMC Office for Greenville County in Plat Book KK-111, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern side of Pemberton Drive at the joint front corner of Lots 7 & 8, and running thence with the line of Lot 8, S. 21-45 W. 266.4 feet to an iron pin; thence S. 86-46 E. 209.8 feet to an iron pin at the joint rear corner of Lots 6 & 7; thence with the line of Lot 6, N. 7-31 E. 223 feet to an iron pin on the southern side of Pemberton Drive; thence with the southern side of Pemberton Drive and following the curve thereof, the chord of which is N. 74-45 W. 145 feet, to the point of beginning.

This being the same property conveyed to the Mortgagors herein by Deed of Max S. Turner, which Deed is dated April 30, 1979, and is to be recorded herewith in the RMC Office for Greenville County.

In addition to and together with the monthly payments of principal and interest under the terms of the Note secured hereby, the mortgagors promise to pay to the mortgage a monthly premium necessary to carry private mortgage guaranty insurance until the principal balance reaches 80% of the original sales price or appraisal, whichever is less. The estimated monthly premium for the first nine years will be .02% of the original amount of the loan. The estimated monthly premium for each year thereafter will be .01% of the original principal balance of this loan. The mortgage may advance this premium and collect it as part of the debt secured by the mortgage if the mortgagors fail to pay it.

Borrower covenants that Borrower is lawfully seised of the estate hereby conveyed and has the right to mortgage, grant and convey the Property, that the Property is unencumbered, and that Borrower will warrant and defend generally the title to the Property against all claims and demands, subject to any declarations, easements or restrictions listed in a schedule of exceptions to coverage in any title insurance policy insuring Lender's interest in the Property.
