All that certain piece, parcel or lot of land together with all the improvements thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown and designated as Lot \(\frac{1}{2} \) 312 of a Subdivision known as Botany Wood, Section VII, according to a plat thereof prepared by Piedmont Engineering Service, dated June 1962, and recorded in the R.M.C. Office for Greenville County in Plat Book YY at Pages 76 and 77, and said lot being more particularly shown and delineated on a plat prepared for Luther H.
