WHEREAS, Hampton Investors Corporation of Greenville has made, simultaneously with the execution of the within Modification Agreement, a payment against said outstanding indebtedness of \$6,486.34, thereby leaving an unpaid balance due and owing of principal and interest in the amount of \$15,000.00.
