This conveyance is made subject to any and all easements, rights of way and restrictions affecting said property or as shown on said plat.

This being the same property conveyed to Mortgagor herein by deed recorded in Dood Book 1105 at Page 916 in the R.M.C. Office for Greenville County.

In addition to and together with the monthly payments of pricipal and interest under the terms of the Note secured hereby, the mortgagor promises to pay to the mortgagee a monthly premium necessary to carry private mortgage guaranty insurance until the pricipal balance reaches 80% of the original sales price or appraisal, whichever is less. The estimated monthly premium for the first nine years will be .02% of the original amount of the loan. The estimated monthly premium for each year thereafter will be .01% of the original principal balance of this loan. The mortgagee may advance this premium and collect it as part of the debt secured by the mortgage if the mortgagor fails to pay it.
