hereinafter referred to as Mortgagee, as evidenced by the Mortgagee's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Thirteen Thousand Two Hundred and 00/100 Dollars (\$13,200.00) due and payable in 60 monthly installments of \$220.00 with the first payment being due July 22, 1979 and the final payment being due June 22, 1984.

+ 6% interest thereon from date of the rate of 15.00 per centum per annum, to be paid monthly.

WHEREAS the Mortgagor, by hereinafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes;

NOW, ANOR ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of and other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagee in hand, well and truly paid by the Mortgagee stand before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville

ALL that piece, parcel or lot of land, situate lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot No. 216, Section 1, of Valleybrook Subdivision, according to a Plat thereof recorded in the RMC Office for Greenville County in Plat "vol. 11" at Page 60, and having according to said plat such metes and bounds as shown thereon.

This being the same property conveyed unto the Grantor herein by deed from Bankers Trust of South Carolina, recorded March 12, 1977, in Deed Volume 1032, at Page 942, in the RMC Office for Greenville County.
