ALL that certain piece, parcel or lot of land situate, lying and being in the County of Greenville, near the City of Greenville, in the State of South Carolina, being known and designated as Lot No. 130 on plat of COACH HILLS, recorded in the R.M.C. In addition to and together with the monthly payments of principal and interest under the terms of the Note secured hereby, the mortgagor promises to pay to the mortgagee a monthly premium necessary to carry private mortgage guaranty insurance until the principal balance reaches 80% of the original sales price or appraisal, whichever is less. The estimated monthly premium for the first nine years will be .02% of the original amount of the loan. The estimated monthly premium for each year thereafter will be .01% of the original principal balance of this loan. The mortgage may advance this premium and collect it as part of the debt secured by the mortgage if the mortgagor fails to pay it.
