

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of

Twenty one thousand seven hundred forty dollars and holdes

DOLLARS

(\$ 21,710.10), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is 10 years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

All that lot land situate on the Northwestern side of Darlington Avenue, in the County of Greenville, State of South Carolina, being shown as Lot No. 7 on a plat of the property of Ethel Y. Perry Estate, dated March, 1946, prepared by W. J. Riddle and recorded in plat book Q at page 26 in the RMC Office for Greenville County; and having according to said plat the following metes and bounds to-wit:

Beginning at an iron pin on the Northwestern side of Darlington Avenue at the joint front corner of Lots 6 and 7 and running thence with Lot 6 N 47-30 W 162 feet to an iron pin at the joint rear corner of Lots 6 and 7 and Lot 18; thence with Lot 18 N 5-35 W 55 feet to an iron pin at the joint rear corner of Lots 7,17 and 18; thence with the line of Lot 17 N 84-28 E 33.8 feet to an iron pin at the joint rear corner of Lots 7 and 8; thence with Lot 8 S 47-East 182.4 feet to an iron pin on the Northwestern side of Darlington Avenue. Then with Avenue S 43 W 60 feet to the point of beginning.

This conveyance is subject to any and all existing reservations, easements, rights-of-way, zoning ordinances and restrictions or protective covenants that may appear of record or on the premises.
