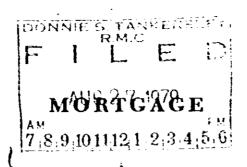

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, near the East of the City of Greenville, and being known and designated as Lot Number 42 of a subdivision known as Terra Pines Estates, Section 4, a plat of which is of record in the R.M.C. Office for Greenville County in Plat Book OOO at page 85, and having the following metes and bounds, to wit:

BEGINNING at a point on the Southeastern side of Doyle Drive at the joint front corner of Lots 41 and 42 and running thence with the Southeastern side of Doyle Drive S 25-28 W 265 feet to a point; thence following the curvature of the Northeastern intersection of Doyle Drive with Burke Street (the chord of which is S 12-24 E) 39.5 feet to a point; thence with the Northeastern side of Burke Street S 50-15 E 176.9 feet fo a point at the joint corner of Lots 34 and 42; thence N 19-30 E 227.3 feet to a point; thence N 22-10 E 114.1 feet to a point at the joint rear corner of Lots 41 and 42; thence N 64-32 W 166.3 feet to a point on the Southeastern side of Doyle Drive at the point of BEGINNING.

This deed is executed subject to existing and recorded restrictions and rights of way.
