NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

'ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being Greenville, on the easterly side of Jones Avenue, in the State of South Carolina, County of being shown and designated as Lot 9 and a small triangular portion of adjoining Lot 10 on a Plat of Property of David L. Dawkins and Rosa Lee Dawkins, recorded in the RMC Office for Greenville County in Plat Book 4-I, at Page 35, and having, according to said Plat, the following metes and bounds:

BEGINNING at an iron pin on the eastelry side of Jones Avenue, joint front corner of Lots 8 and 9, and running tehnice with the common line of said Lots, S 85-00 E, 230 feet to an iron pin; running thence S 5-00 W, 60 feet to an iron pin, joint rear corner of Lots 9 and 10; thence on a new line through Lot No. 10, N 86-35 W, 218.2 feet to an iron pin on the easterly side of Jones Avenue; thence with said Avenue, N 5-10 W, 67 feet to an iron pin, the point of beginning.

This is the same property conveyed to the Mortgagors herein by deed of James Lewis Dawkins, dated and recorded February 24, 1971, in Deed Book 909, at Page 362.
