

ALL that piece, parcel or lot of land situate, lying and being on the southern side of Bane Road in Greenville County, South Carolina, in Chick Springs Township, being known and designated as Lot No. 3, Section I as shown on a plat entitled WHIPPORWILL HILLS recorded in Plat Book 4-N at Page 20 and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern side of Bane Road at the joint corner of lot no. 2 and running thence along said road, S. 78-15 E. 168.5 feet to an iron pin; thence S. 12-20 W. 174.7 feet to an iron pin; thence N. 66-24 W. 170 feet to an iron pin; thence N. 11-36 E. 139.8 feet to an iron pin, the point of beginning.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its heirs, successors and assigns, forever.

The Mortgagor covenants that it is lawfully seized of the premises hereinabove described in fee simple absolute, that it has good right and is lawfully authorized to sell, convey or encumber the same, and that the premises are free and clear of all liens and encumbrances except as provided herein. The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagee forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.

The Mortgagor further covenants and agrees as follows:

(1) That this mortgage shall secure the Mortgagee for such further sums as may be advanced hereafter, at the option of the Mortgagee, for the payment of taxes, insurance premiums, public assessments, repairs or other purposes pursuant to the covenants herein. This mortgage shall also secure the Mortgagee for any further loans, advances, readvances or credits that may be made hereafter to the Mortgagor by the Mortgagee so long as the total indebtedness thus secured does not exceed the original amount shown on the face hereof. All sums so advanced shall bear interest at the same rate as the mortgage debt and shall be payable on demand of the Mortgagee unless otherwise provided in writing.
